Synopsis:	Victim reported that she has received a large amount of emails making threats against her reputation.

Narrative:	<p>On listed date and time, I was dispatched to _____ for a harassment report. Prior to my arrival, I call and talk to the victim in order to see if there was a reportable offense involved since the harassment involved emails which are sometimes hard to determine who the offender would be. After talking to the victim, I determined that her complaint had merit and decided to meet with her in order to take a report. Upon arrival, The victim identified herself as Channa L. Capeland _____ Channa told me that she has her own company called North Star Case Management and she is a certified Professional Guarding.</p> <p>Channa explained that in November 2018, she became the legal guarding of a vulnerable adult. Channa identified the vulnerable adult as Omana Thankamma _____. Since then, Channa has attempted to make medical care arrangements with Omana's son who she identified as Jayakrishnam K. Nair 05/09/1980. Channa showed me a Seattle Police Department's Case _____ which had all the identifying information matching the names and date of births she provided for Omana and Nair (Jay).</p> <p>Channa said that Nair has had a problem accepting the fact that Channa is the legal guardian of Omana and is allowed to make decisions about her healthcare. Furthermore, Nair has recently been banned from visitation at Paramount Rehab in Seattle, which is the facility where Omana is staying. This has caused Nair to send an extensive ammount of emails to Channa in which he consistently makes threats to create websites or go to media sources if Channa does not agree to let Omana be moved to Nair's house or to another facility of his choosing.</p> <p>Nair has also wrote Channa's home address in an email and has made references to Channa's family.</p> <p>Although, Channa is used to dealing with many types of personalities and characters, Nair's emails has caused Channa to fear for her and her families' safety since Nair has shown he knows where she lives and has made references to her family. Furthermore, while talking to Channa, she searched for her name online to see if Nair had posted anything about her as he claimed he would.</p> <p>Channa provided me with multiple emails and here are some statements from Nair that caught my attention:</p> <ul style="list-style-type: none"> <li>- "Roger will not save you from the consequences nor will anyone else"</li> <li>- "I have not made the press release yet"</li> <li>- "I am sorry, please Google your name. We have decided to go public"</li> <li>- "We already told you we have to have a plan in place before tonight or we have to do what it takes to save her from that hell"</li> <li>- "Karma will get you, and so will Seattle times"</li> <li>- "It is not going to go well if you try to play the blame game to add more restrictions between us"</li> <li>- "Smile, you are going to be FAMOUS!!"</li> <li>- "Do you really want to make this ugly..."</li> <li>- "Please don't get drunk on the koolaid from Roger again. I have held off on my plan in the hopes that we can work this out together"</li> <li>- "I will wait for your call until I must do the press release today afternoon"</li> <li>- "You have until noon today to confirm she has been moved to a safe location, failing which I urge you may NOT want to google your own name ever again, and delete all your social media accounts..."</li> <li>- "By noon she must be at another safe facility or you can google your name to see what the public will see."</li> </ul>

- "...and you have already dug yourself into a home with the Lis Pendes on your properties at

- "YOU CAN RESPOND TO ME IN THE NEXT HOUR OR YOU CAN RESPOND TO JOURNALISTS LATER IN THE DAY"
- "...and as long as you cooperate, it will be in the best interests of BOTH of our families"

Nair has repeatedly threatened Channa over email with posting about her online and going to news media sources if she does not comply with his demands by using her power as a Certified Professional Guardian and Legal Guardian of Omana to move Omana to his home or a different health care place of his own choosing.

As of this time, I have not contacted Nair because from reading his emails, I believe if he learns that Channa has contacted law enforcement about him, it will only escalate his behavior.

I was able to determine that Nair's email address is Jknair@gmail.com from the emails provided by Channa, which show that Nair uses that email address not only to communicate with her, but with his former private lawyer.

I talked to Channa about why would she not report this through Seattle Police Department and she explained that SPD referred her to us since her home office is her residence .

I have attached copies of all the emails Channa provided and a onenote document that appears to be written by Nair, which describes his side of the whole story and discredits anyone that appears to disagree with him.

As of now, I recommend for charges to be forwarded to Pierce County prosecutors for review regarding Cyberstalking and Extortion.

Narrative:	<p>At the beginning of my shift today (1900 hours), I noticed a pending call regarding this case and responded to it. Upon arrival, I met with Channa. Channa explained that Nair had sent her a letter through the mail. She brought special attention to the last page of the letter in which Nair wrote "it will behoove your own family to make sure you stop messing with ours and not try to pry us apart, as we take our mother's pain very very seriously."</p> <p>Channa continues to be in fear for her safety and her family since Nair continues to mention her family and has shown that he knows her personal address.</p> <p>During my conversation with Channa, I informed her that the Pierce County Prosecutor declined to file charges for the case. I could tell that Channa became upset about the news but she maintained her composure. I told Channa that she should look into getting a no contact/protection order in order to prevent further contact from Nair.</p>

I further advised Channa that I would talk to the City of Orting Prosecutor to see if he could pick up the case for misdemeanor charges.

Channa explained that she will contact the Pierce County Prosecutor's office herself to ask for them to further review the case. She further explained that she is really good about suing people for not doing their job and she may end up suing the Pierce County Prosecutor's office or Orting Police Department if she is to find out someone is not doing their job.

As of now, I am updating the report with the information she provided me and will provide the letter she received to records in order to be attached to the case.
